However, as per our records, your last date of working with the Company was as of close of business hours on 08-OCT-24 . Accordingly, please note that you have only served 14 days of your notice period.


Accordingly, while your last working day with the Company was 08-OCT-24, due to shortfall in notice period on your account you stand relieved from the Company on 08-OCT-2024.
