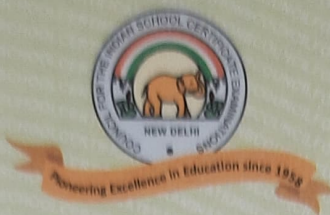

I. EXTERNAL EXAMINATION

Awards and conditions for awards:
