C<sub>ni</sub> - number of credits of the i<sup>th</sup> course of the n<sup>th</sup> semester.


M<sub>ni</sub> - marks of the i<sup>th</sup> course of the n<sup>th</sup> semester.

G<sub>ni</sub> - grade points of the i<sup>th</sup> course of the n<sup>th</sup> semester.


**Division:-**
