I am writing to formally request an early release from my current role, with my last working day being **24th October 2025**. I received an offer from another organization with a joining date of **27th October 2025**, and I would be grateful for your support in facilitating this transition.

To provide some context, I joined the organization on **14th April 2024** and have been in regular touch with my counsellor regarding my probation status. Despite my continuous follow-ups, my probation was not confirmed until recently. On **14th July 2025**, I reached out to HR to confirm my probation status, and I was informed that it was still not confirmed at that time. Additionally, some mandatory trainings were still pending.
