This document is issued in accordance with the provisions of the Employment Rights Act 1996 and sets out the main terms and conditions of work under which you are employed by the Company.

Your employment will be subject to the terms of this Contract of Employment which forms the entire agreement between us.

**Name of the Employing Company:** Five Guys JV Limited, Unit 2-3, 1 Bard Road, London, W10 6TP ("Company")

#### Place of Work

You will generally be located at Portobello, London restaurant although you will be required to be flexible and work in any of our locations within a reasonable distance from your current place of work depending on business needs.

#### Commencement of Employment

Your employment under this Agreement will commence on 27 May 2022 and no employment from any other employer will be considered continuous.

#### Job Title

You will be employed as a Crew Member but you may be required to undertake other reasonable duties from time to time in order to fulfil the needs of our business.

#### Hours of Work

Your basic hours of work is 16 hours. You may be required to work on any day of the week and on bank and public holidays. Days and timing of your shifts will be notified at least two days in advance. Additional hours are not guaranteed but you maybe required to work additional or fewer hours at the Company's discretion in accordance with its business needs.

If you have accepted an offer of work, you are obliged to complete it and will be entitled to a 20-minute break when you work for 6 hours or more in a shift. You may be required to work outside these hours as are necessary for the proper performance of your duties at your hourly rate.

You may execute an opt-out agreement, which can be obtained from your manager, which will allow you to work in excess of 48 hours per

On leaving the Company's service employees will be entitled to payment in lieu for accumulated holiday in the calendar year, less any holidays taken. If you have taken more holiday than your accrued entitlement at the date your employment terminates, we shall be entitled to deduct from your final salary payment.

#### Statutory Sick Pay

You must notify your Manager of the reason for your absence as soon as possible but no later than 2 hours prior to the start of your shift. Subject to meeting the statutory sick pay requirements, you will be eligible for Statutory Sick Pay. Further details of Statutory Sick Pay can be obtained from your Manager.

#### Probationary Period

Your employment with us will be on the basis of a probationary period of thirteen (13) weeks, during the first 4 weeks no notice of termination of employment is required by either party, thereafter not less than one (1) weeks' notice of termination of employment is required by either party until the end of your probationary period.

The Company will assess and review your work performance during this period and this gives you the opportunity to assess your suitability to the role and company.

#### Notice Periods

After successful completion of your probationary period you will be required to give not less than two (2) weeks' notice in writing of termination of your employment. The Company will provide two (2) weeks' notice during the first two years of employment and one (1) additional weeks' notice for each complete year of service after two years up to a maximum of 12 weeks' notice for 12 years.

The Company reserves the right at its own discretion to pay you in lieu of the above notice periods. If the Company exercises its discretion to pay you in lieu of notice, your employment will terminate accordingly and you will not be entitled to any benefits or payment in lieu of benefits in respect of your notice period nor to any additional payment in respect of holiday which but for the termination of your employment would have accrued.

### Pay

### Holidays

You are entitled to the equivalent of 28 days' holiday during each holiday year (including public and bank holidays), calculated on a pro rata basis depending on the number of hours that you actually work. Your holiday entitlement is therefore equivalent to 12.0% of the hours worked in each holiday year. You will be paid your normal basic pay during such holidays.

If your employment starts or ends part way through the holiday year, your holiday entitlement during that year shall be calculated on a pro rata basis. The holiday year operates from 1st April to 31st March.

The Company encourages you to take all your holiday entitled to you in each holiday year and there may be occasions when the Company may have to instruct you of when to take your holidays.

Acceptance of employment is deemed to be consent for such a search, during which you have the right to be accompanied by another member of staff chosen by you.

### Personal information

As part of your employment contract, we may need to process personal information about you where this is necessary for reasonable business purposes including (without limitation) sharing appropriate information on a confidential basis with third party benefits providers and payroll operators. This may involve processing sensitive personal data about you which we hold.

As part of your employment contract, we may need to transmit relevant personal information about you to our other offices or to another Group Company outside the European Economic Area, in particular to the United States, where we reasonably consider this to be necessary to further our business interests. You agree this even where the country in question does not maintain adequate data protection standards.

You must tell us of any changes in your home address and other contact details. It is your obligation to update your on-line personal records.






