Dear Sahitya,

I am writing to formally accept your resignation from Goldman Sachs Services Private Limited with effect from January 21, 2026.

For the sake of clarity, I set out below the terms of your leaving arrangements.

Until January 21, 2026 you remain an employee of the Firm and must continue to act in the Firm's best interests, including but not limited to not interfering with the Firm's relationships with its clients or employees. You will be required to take all actions and do all things that the Firm may reasonably request including to maintain for the Firm the business, goodwill, and business relationships with any of the Firm's clients with whom you worked during the term of your employment, and you will remain subject to all policies and procedures applicable to employees of the Firm. You may also be required to effect an orderly transition of your responsibilities and knowhow acquired in the course of your employment with the Firm.

Please note, under the terms of your employment, you have an ongoing obligation to cooperate fully with the Firm (and its respective counsel, if applicable) in connection with any client matter, inquiry, investigation, administrative proceeding, litigation or dispute relating to any matter relating to the Firm in which the Firm believes you were involved or of which you have knowledge.

Any holiday that you have accrued but have not taken will be paid to you. If you have taken holiday in excess of your entitlement, a deduction will be made from your final salary.

Your relieving letter will be available for you upon completion of the exit formalities to the Firm.

Coverage of benefits under the hospitalization insurance, accidental death insurance and life insurance will continue until January 21, 2026. Should you require further information about this, contact Human Capital Management.

Should you have any outstanding travel and expense claims, please submit them in usual manner within 14 days of the date of this letter.

Please ensure you submit your Exit Checklist prior to your termination date in order to receive your relieving letter.

If you have received any assistance from the Firm that is subject to clawback, you are required to reimburse this amount to the Firm within 14 days from the date of this letter. Cheques are to be made payable to Goldman Sachs Services Private Limited.



Notwithstanding that you are leaving the Firm, you are bound to maintain the secrecy of all confidential information learned during your employment. You are reminded that you signed a Confidentiality Agreement on joining the Firm, the terms of which continue to apply after your departure from the Firm.

In summary, the Agreement states that in connection with your employment with Goldman Sachs you may have had access to non-public or confidential and/or proprietary information and materials concerning the affairs of the Firm or its partners, directors, officers, employees or third parties such as clients and that you must hold all such confidential information and materials in strict confidence. A very serious view will be taken of any breach of these obligations and the Firm may take legal action to protect its interests. Equally the Firm may consider it necessary to write to your employer to notify it of your continuing obligations. You should return to HCM or your manager, no later than your last day in the office, any and all originals and copies of documents and other materials (in whatever form) relating to the Firm or its clients that are in your possession, custody or control including but not limited to confidential and proprietary information and materials.

For the purposes of this letter, the term "Firm" means The Goldman Sachs Group Inc., its subsidiaries and affiliates and its and their respective successors.
