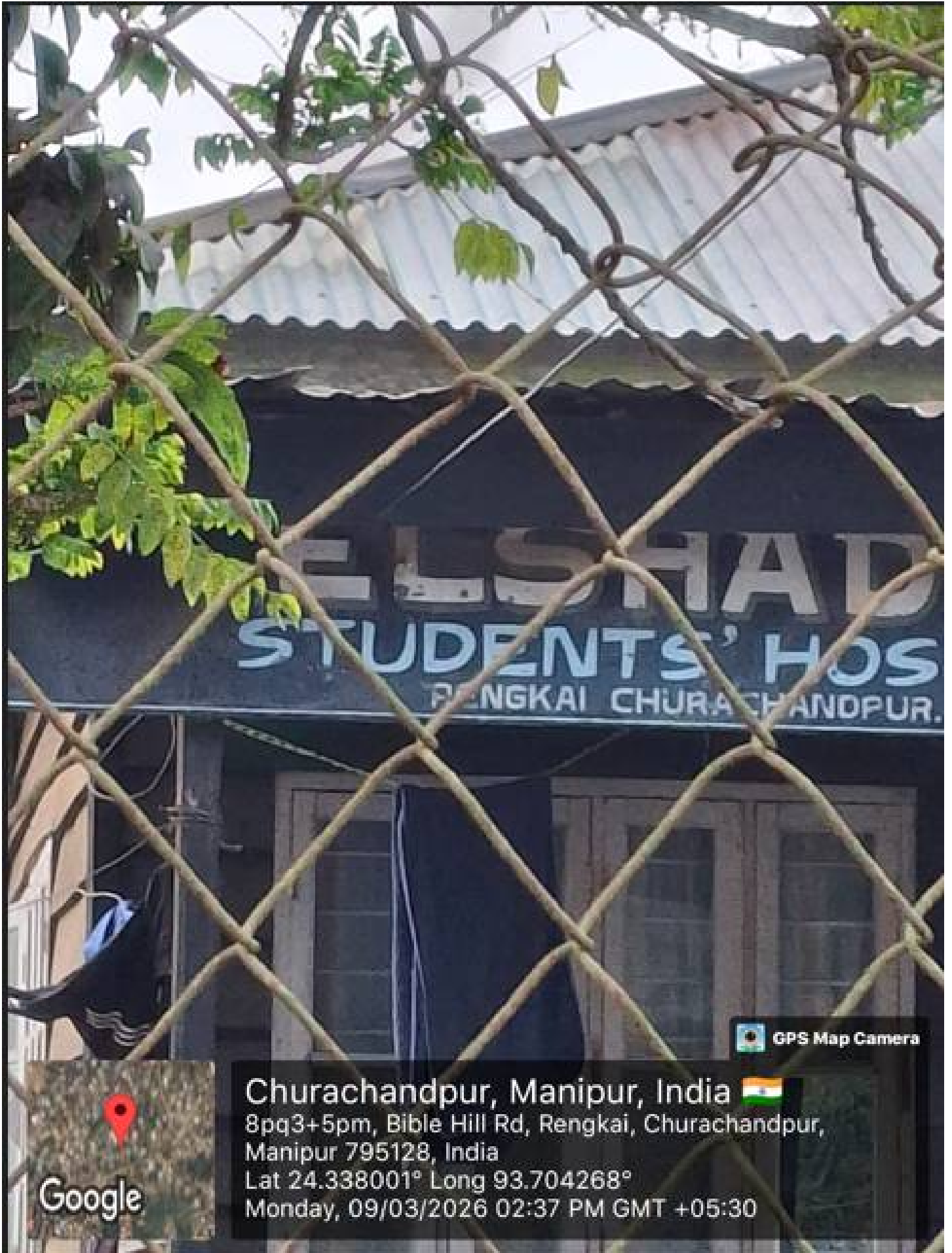


GPS Map Camera

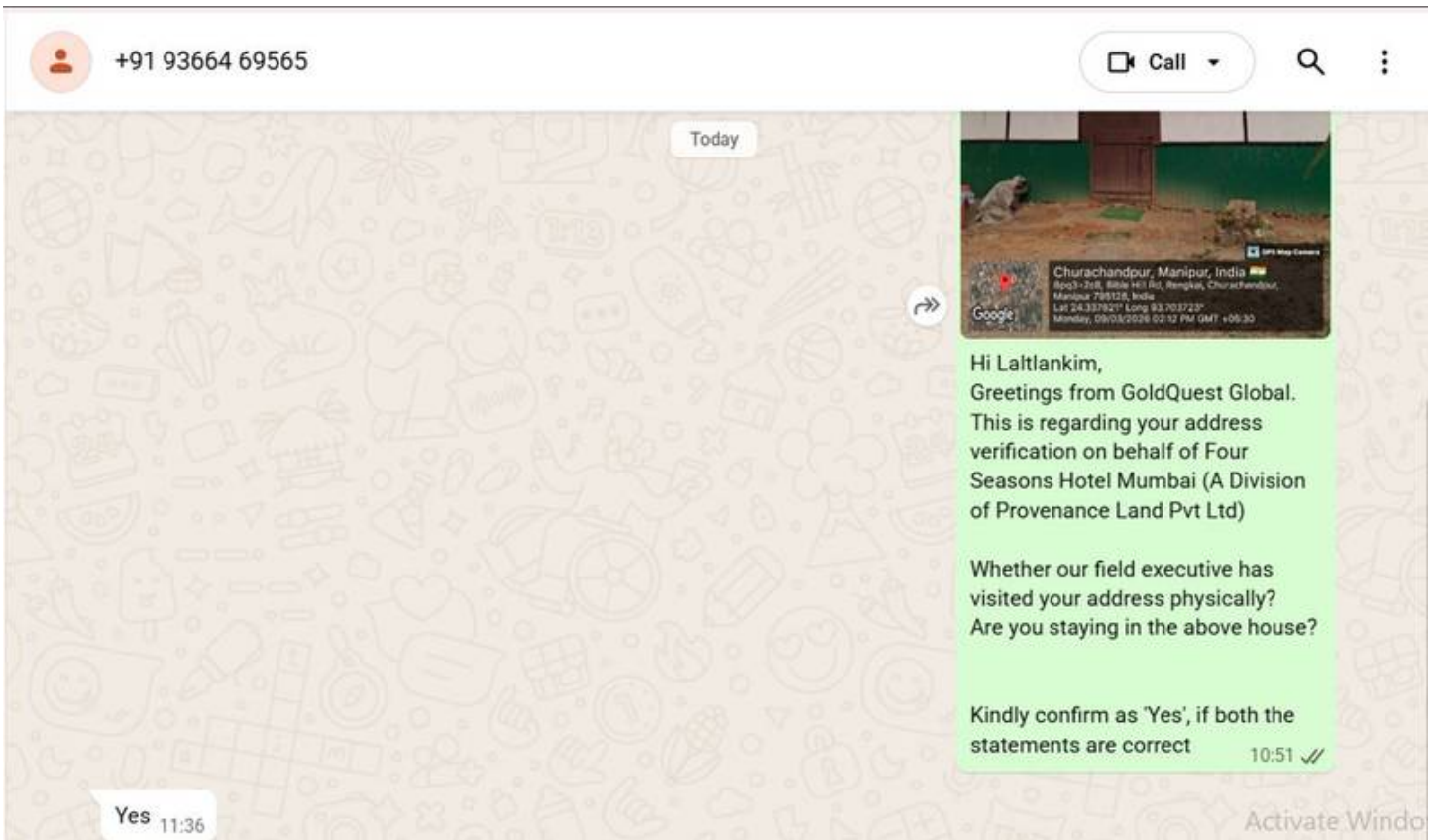
