

#### Reporting:

(a)- You shall report to the " " or any other person nominated by him/her.

#### Date of Appointment:

(a)- This Appointment Letter is effective from the 7<sup>th</sup> DECEMBER 2022.

#### Remuneration:

(a)- Your annual fixed cost to the company would be **Rs.225047/- (Two Lakhs Twenty Five Thousand Fourty Seven Only)** and its detailed break up in Annexure - I is attached for your reference. On successful completion of 6 months probation/training period, you will be promoted as "Quality Control /Assurance Officer" with a revised CTC salary.

(b)- If the employee has rendered services for a period of 5 Years or more, the employee shall be entitled to Gratuity.
