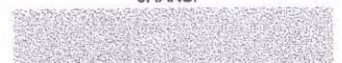

LETTER OF APPOINTMENT

Dear Mr. Ojha,

Greetings and Welcome to **KJS Cement (I) Ltd.** for your appointment as "**Assistant Manager**" in the **Land & Legal** Department effective from **16.10.2024**. The terms and conditions of your appointment will be as follows:

(1) Probation Period-

- 1.1 Your date of birth as per the document submitted by you is **17.12.1999**.
- 1.2 You shall be on probation for a period of six months effective from your date of joining and unless confirmed in writing, you shall be deemed on probation.
- 1.3 Your probation can be extended based on your performance or employment conditions existing at that time for a required period of time.
- 1.4 During the probation period a 7 days notice period/ salary in lieu of notice period will be required to serve from either side.

(2) Confirmation

Upon confirmation of your employment, if you decide to resign, you are required to give a **three months** notice period. (5) **Scope of work**

Any benefits (considered as services), allowances, payouts outside of your salary will be subject to requisite tax liabilities as governed and updated by Govt. of India from time to time.

If you leave the company within a period of one year on your own, all the reimbursement paid to you by company as joining expenses will be required to pay back to company.

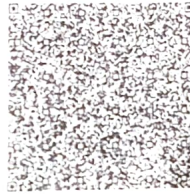
