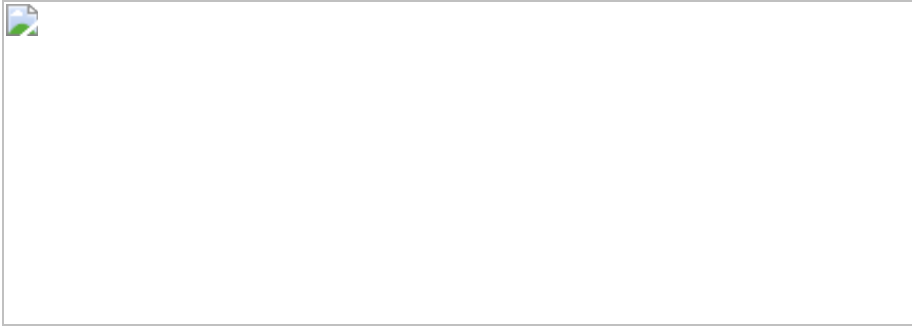
I attempted to retain him with the support of Bhalchandra Sir; however, he remains reluctant to continue. Accordingly, we will need to proceed with relieving him.
