GPS Map Camera



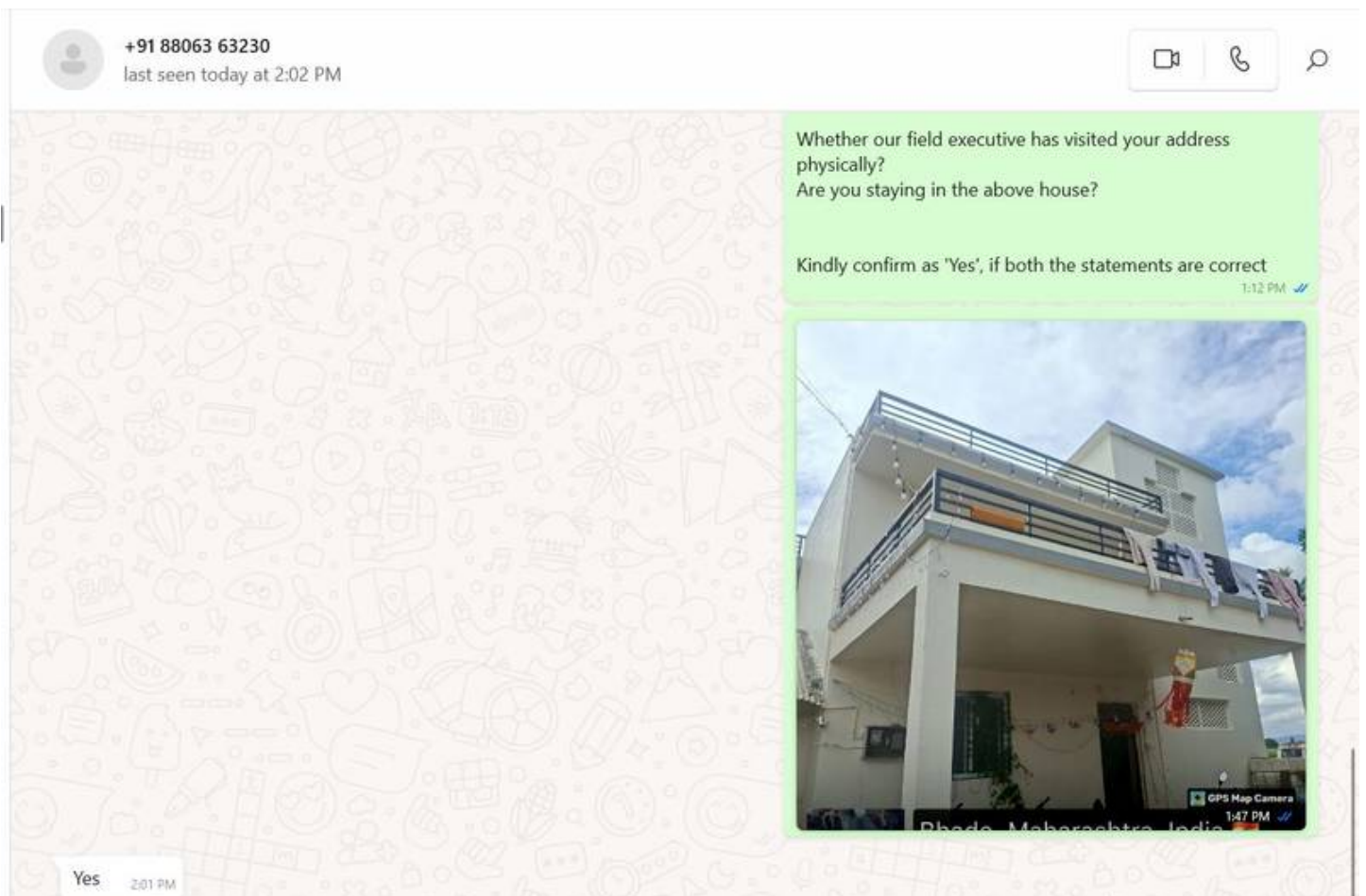
