GPS Map Camera



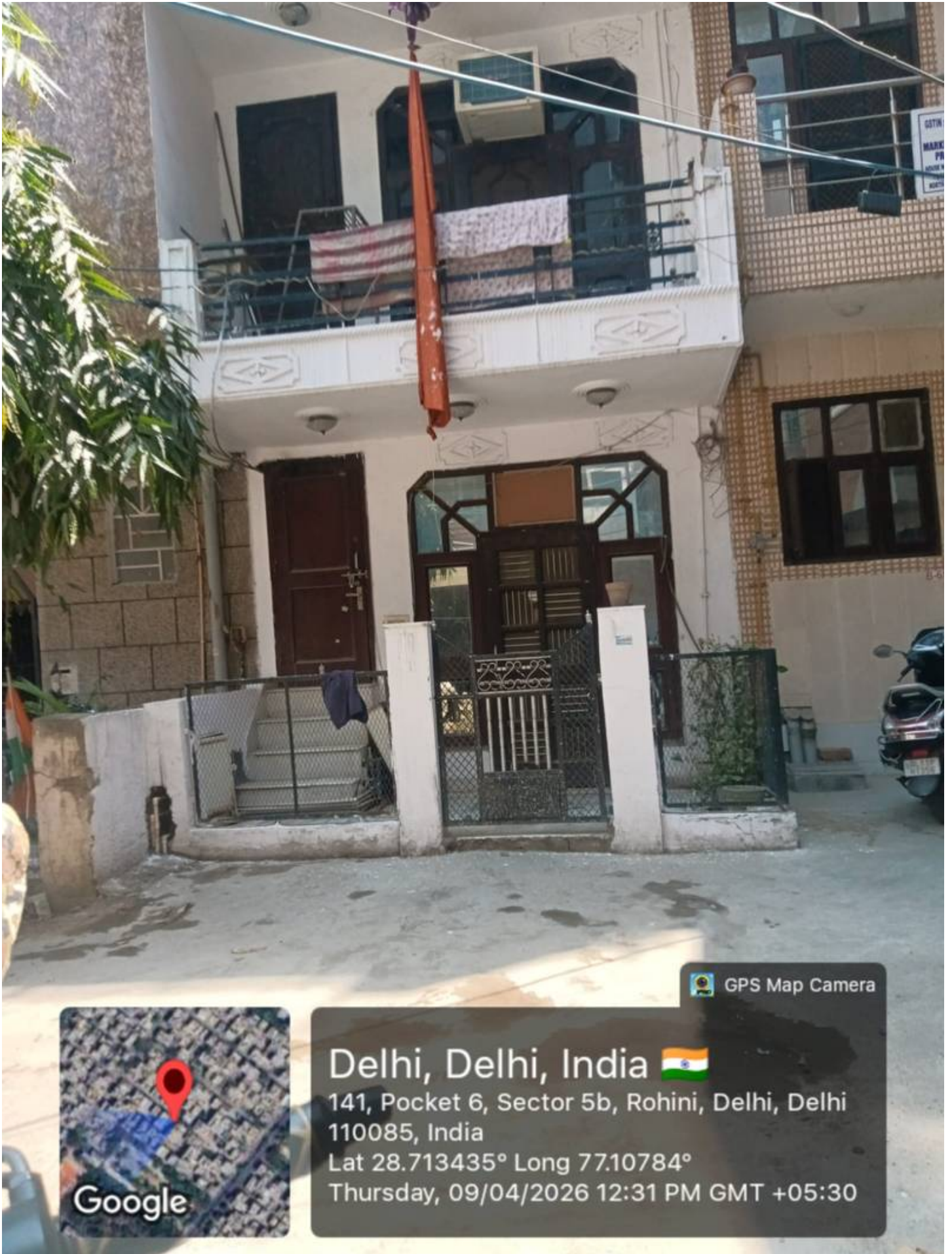
