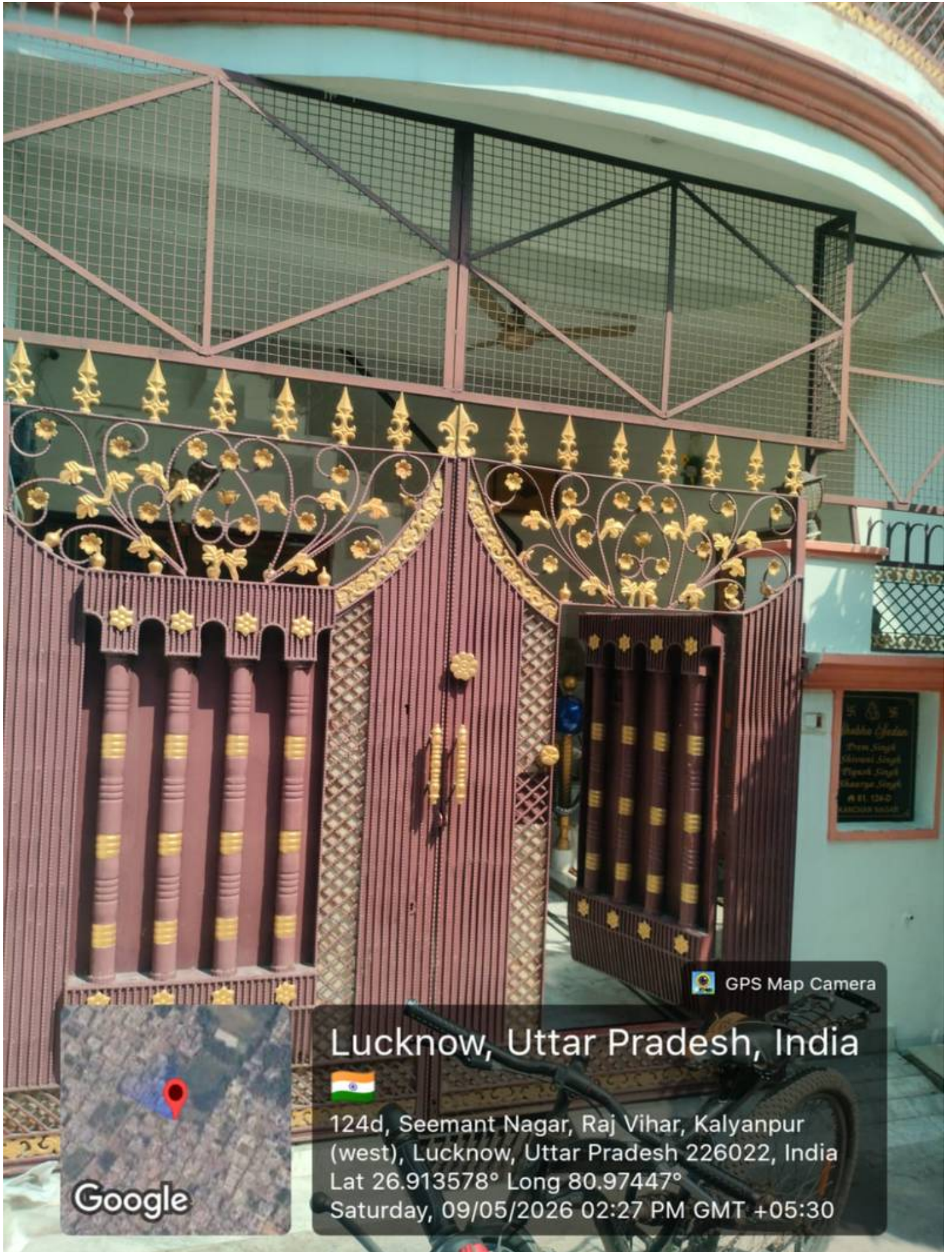

GPS Map Camera

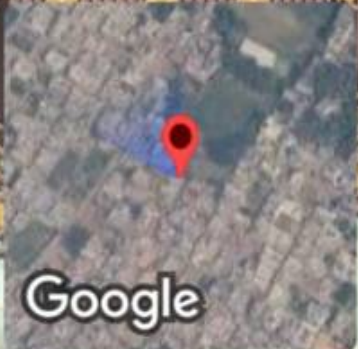

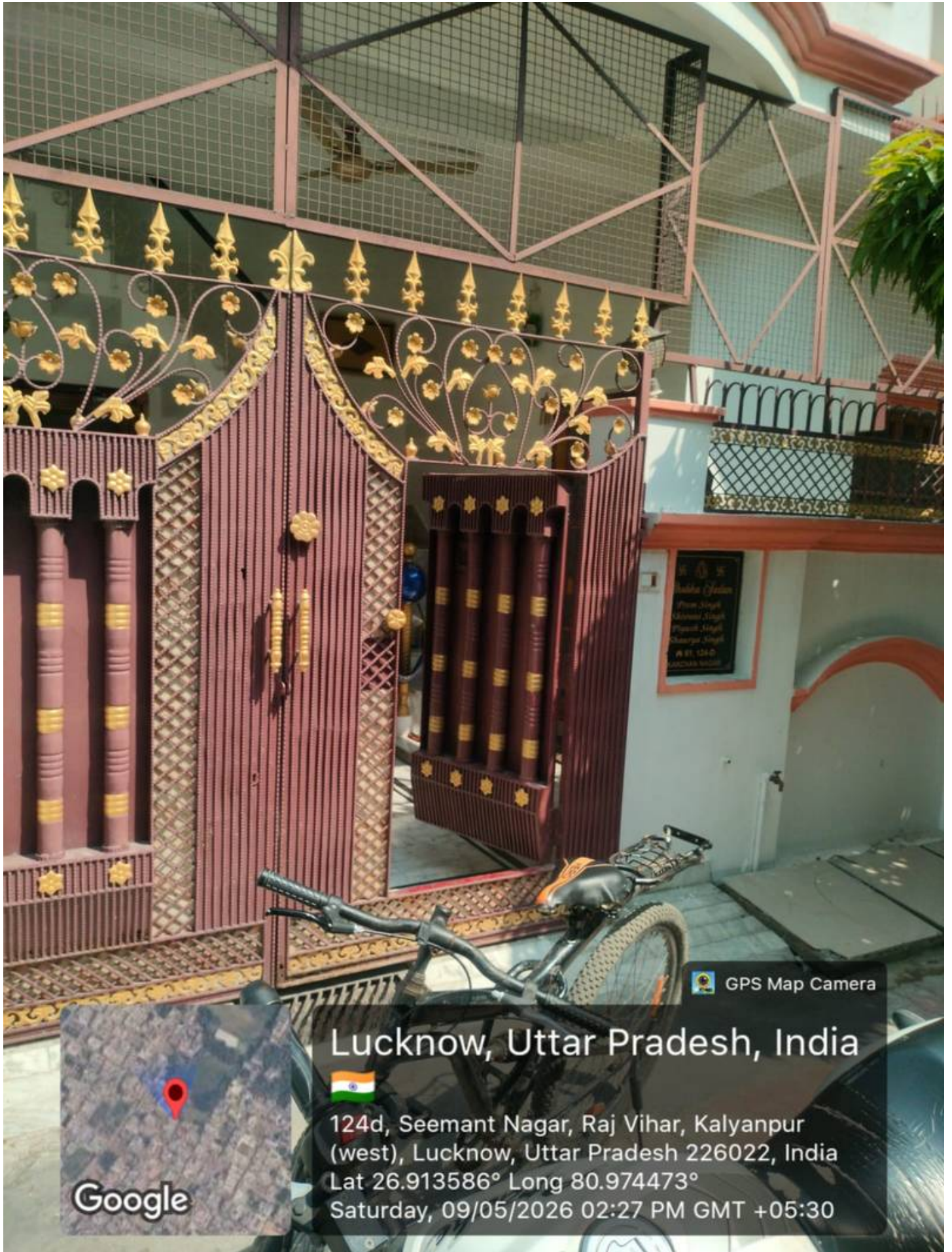

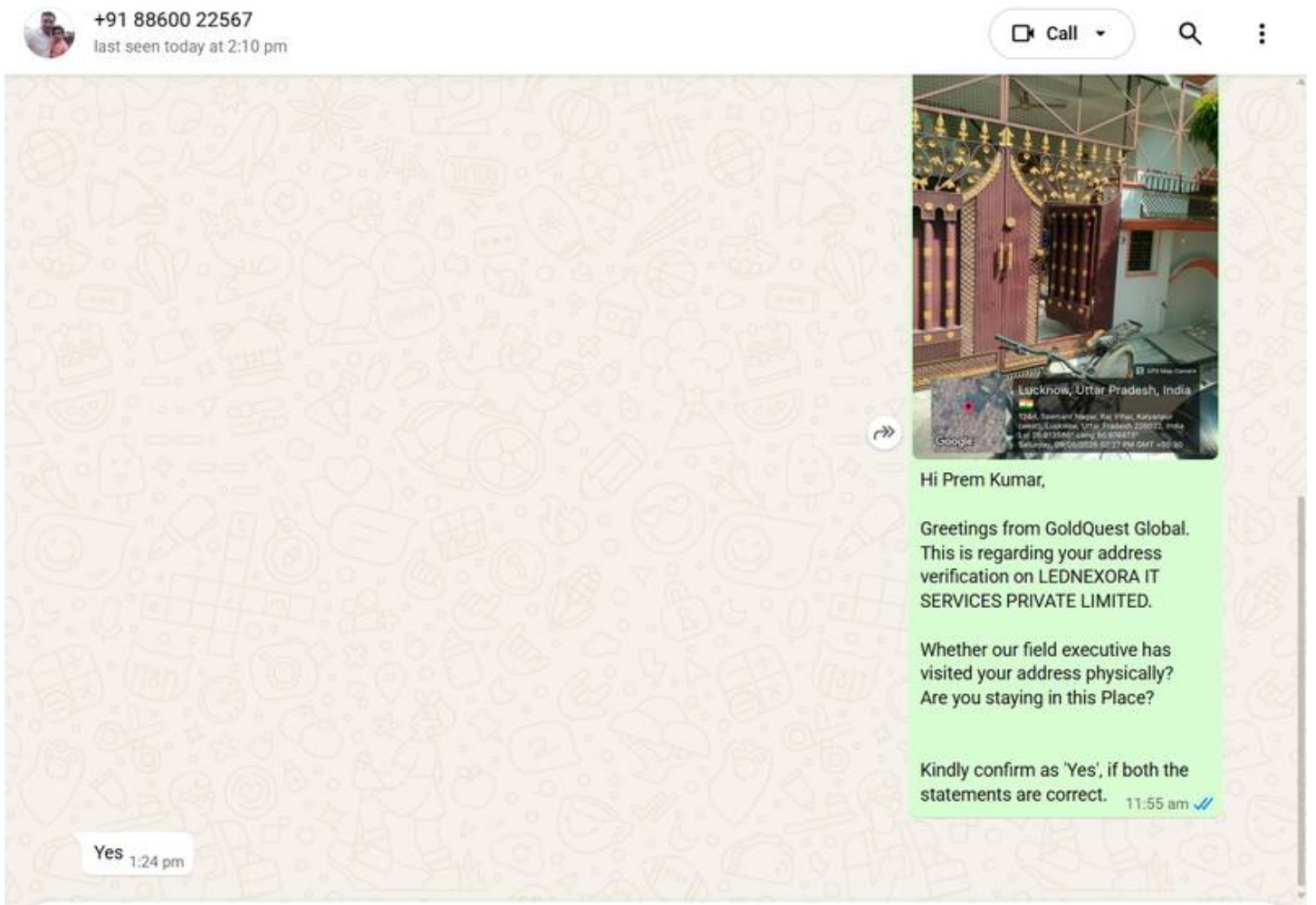
