3. CONFLICT OF INTEREST


- a) During your working hours in the company, you should not engage yourself in any endeavor or activity, which conflicts with the interest and business of the Company.




- b) You will be governed by the Company's Policies, Rules & Regulations that are in force now and that would come into force from time to time as applicable.



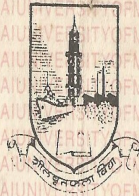
