GPS Map Camera



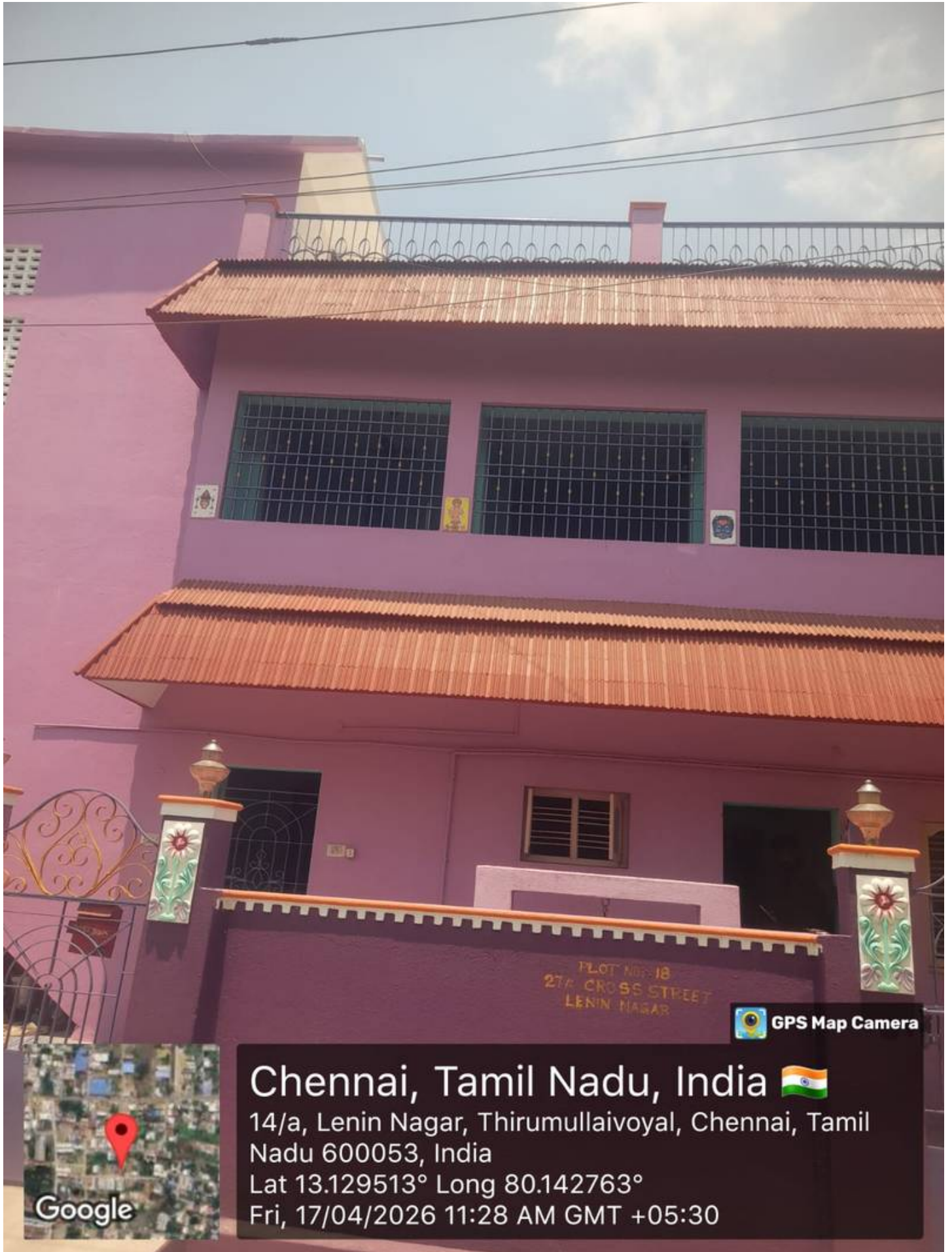

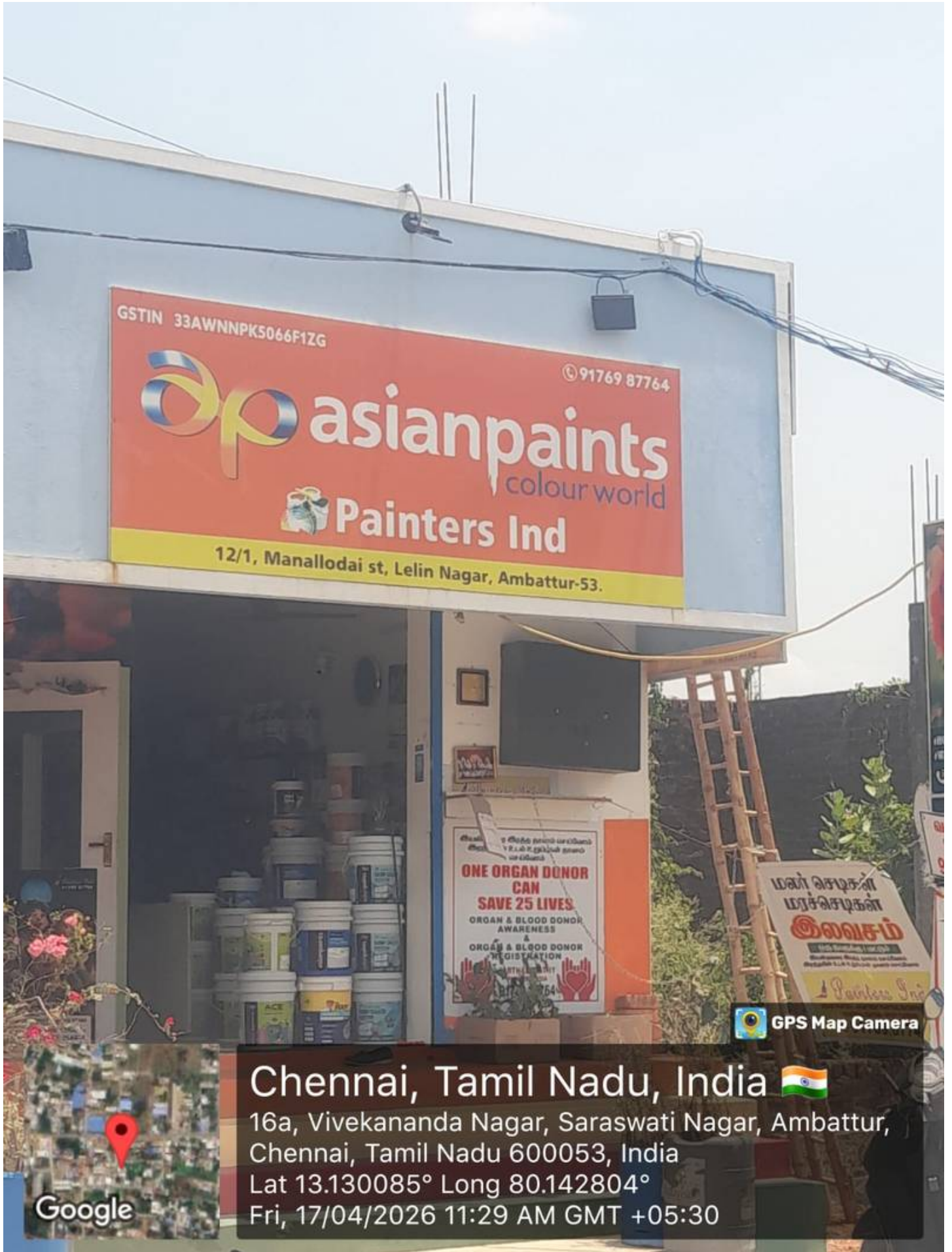

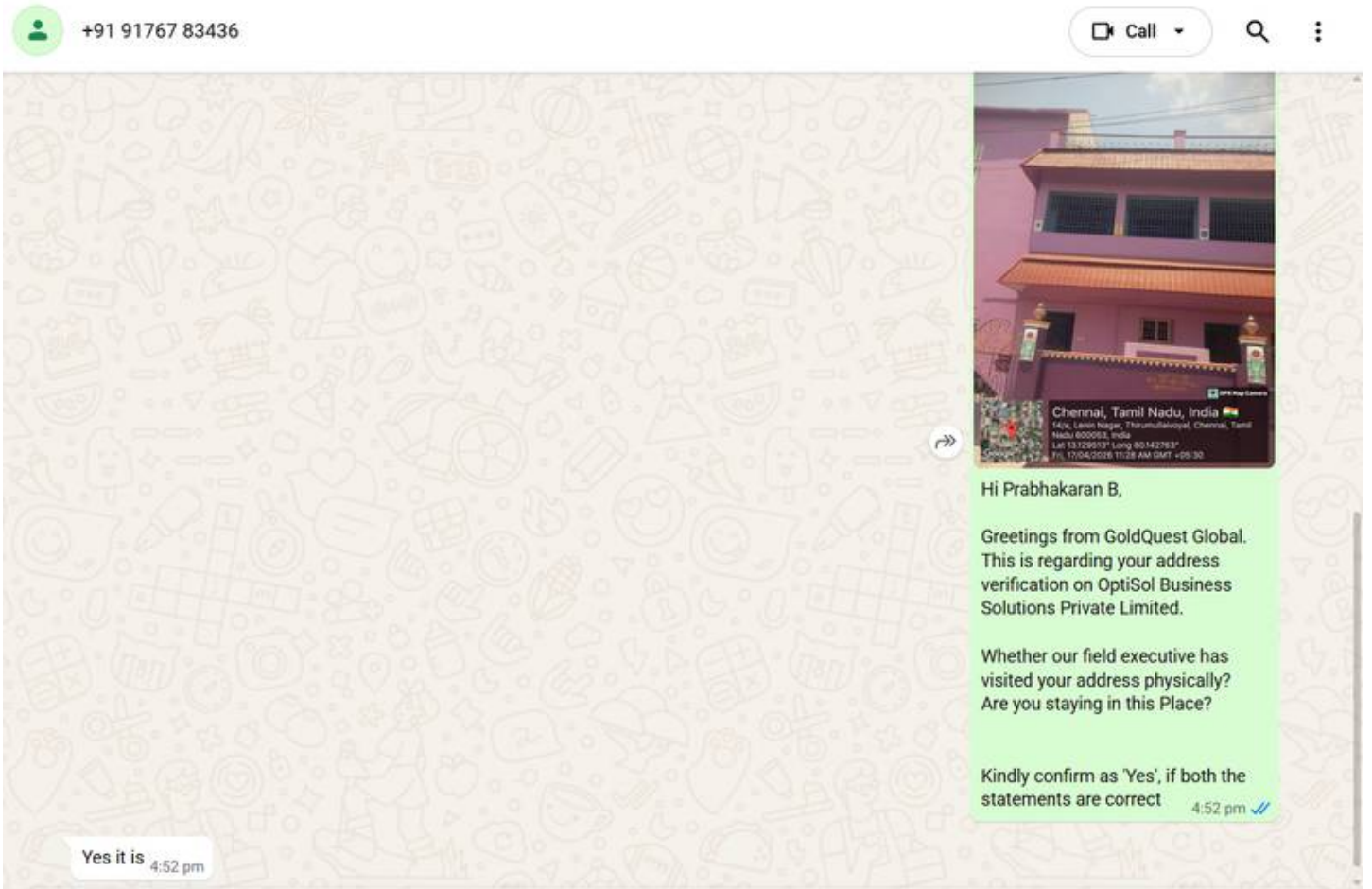
