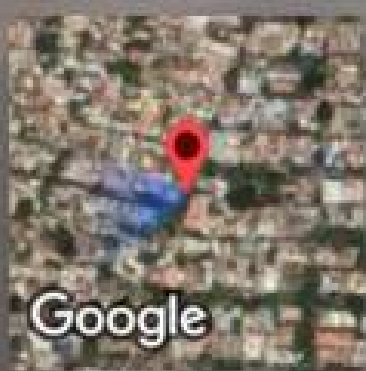

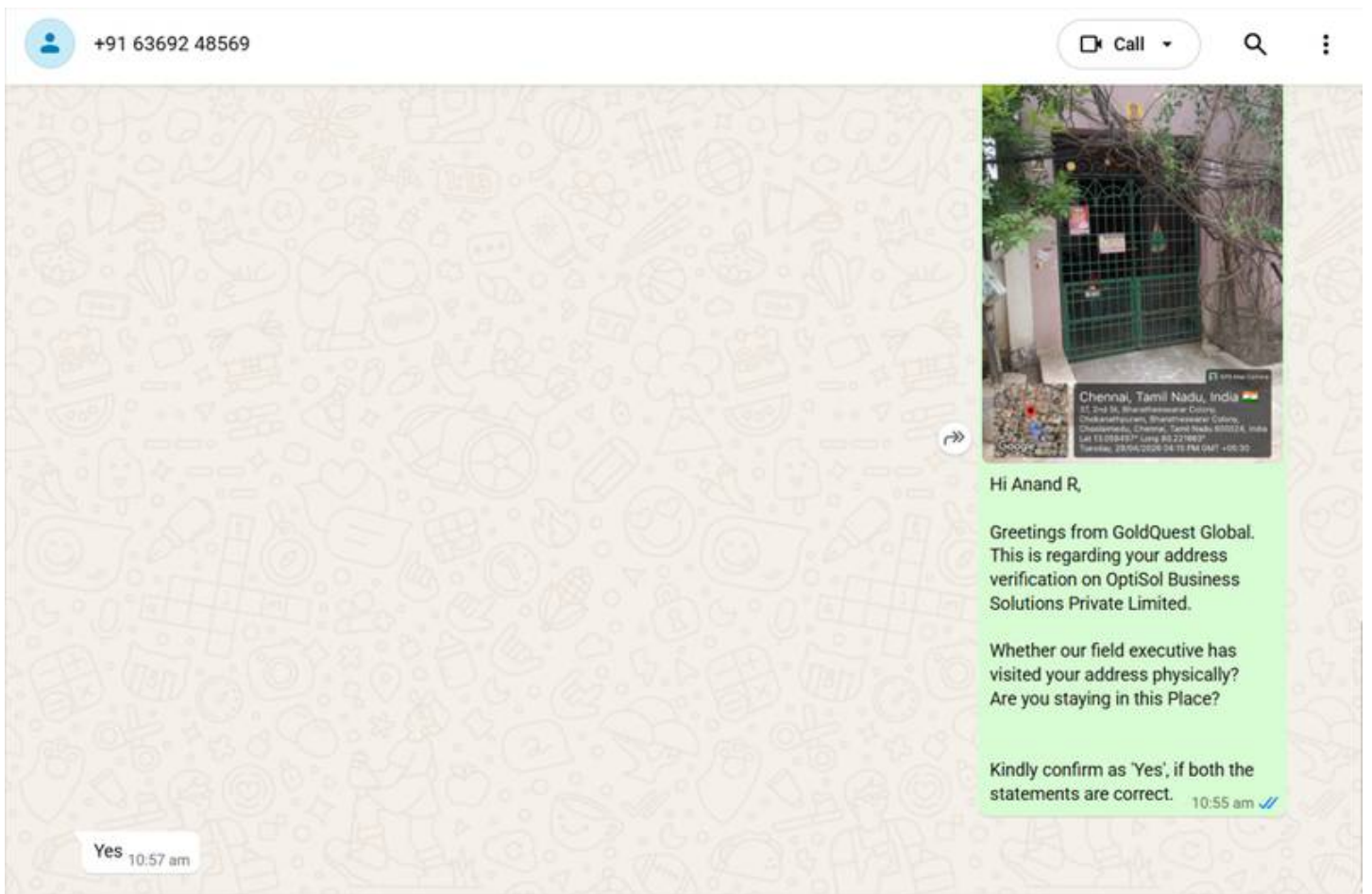


GPS Map Camera

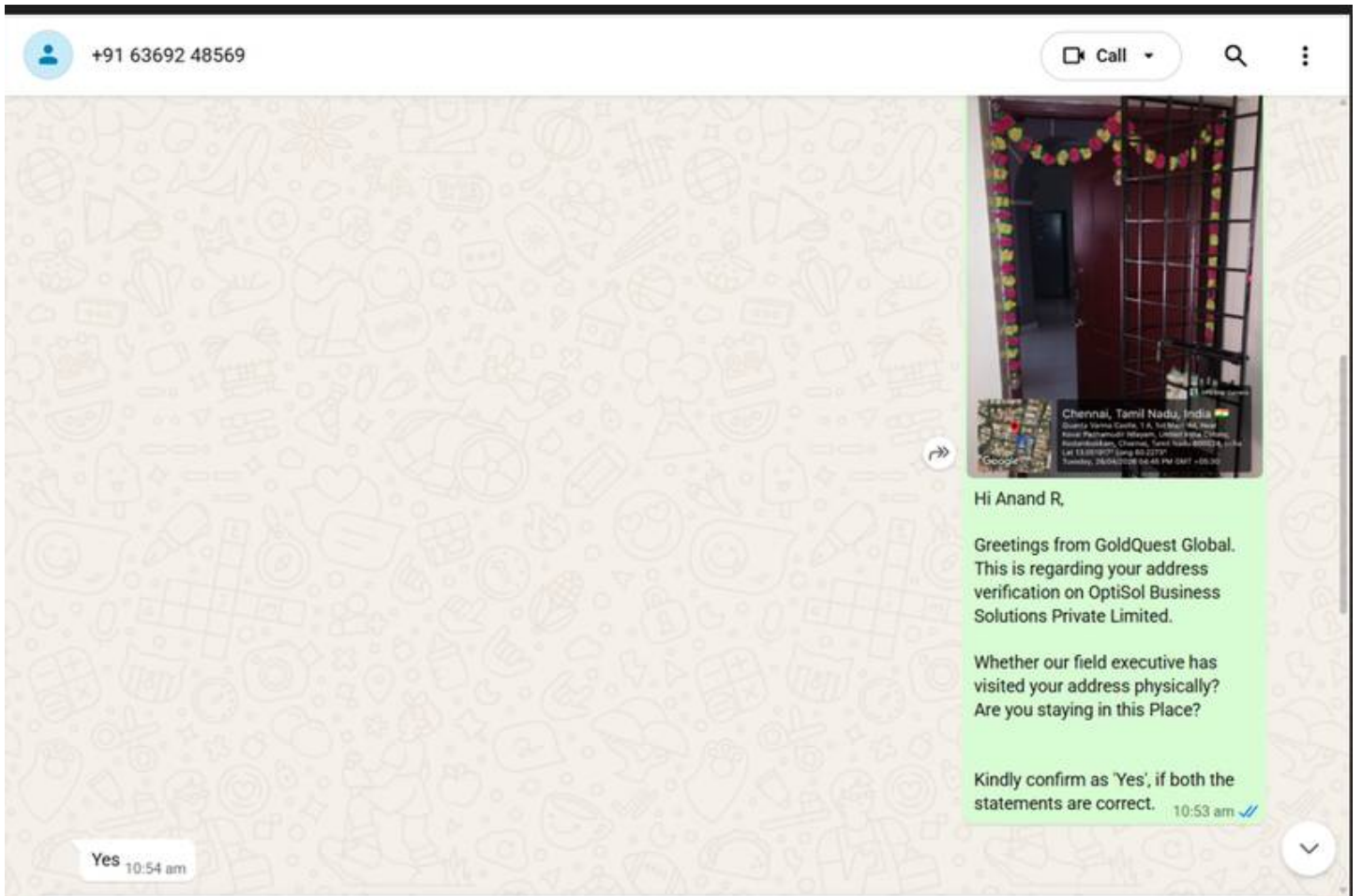
