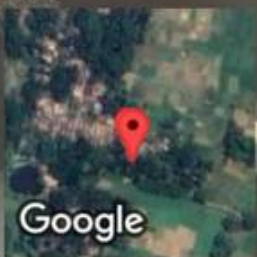

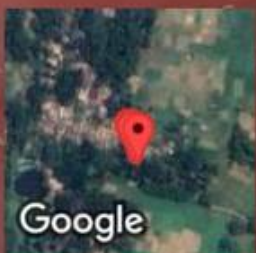

GPS Map Camera



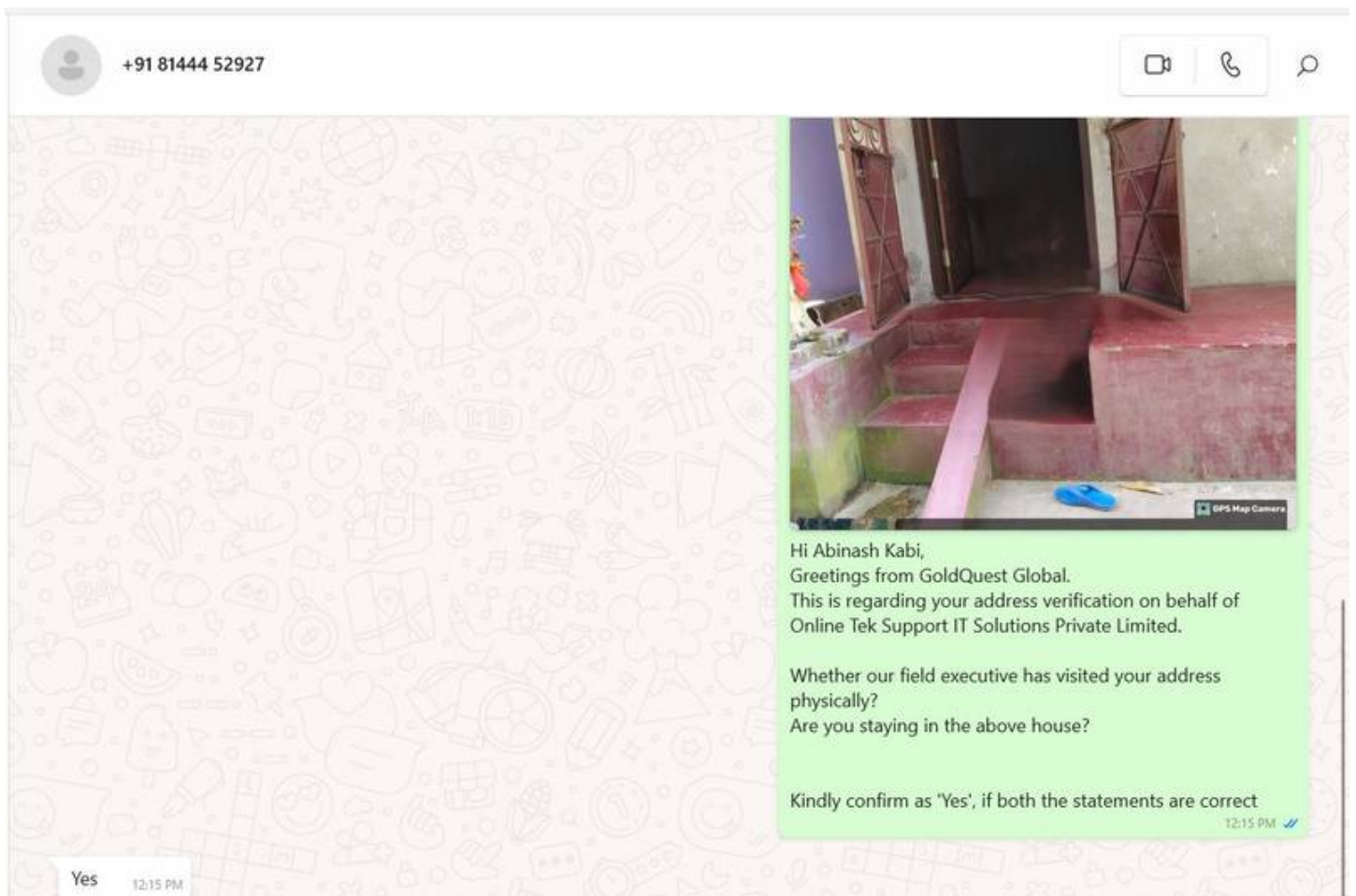
